Mobile Phone and Wearable Technology Policy

Konnect With Sport accepts that mobile technology is part of the ever-changing digital environment that we live and work in. Konnect With Sport fosters a 'culture of safety' in which the children and staff are protected from abuse, harm, and distress. We therefore have a clear policy on the acceptable use of mobile phones, tablet computers and wearable technology that have imaging and sharing capabilities, that is understood and adhered to by everyone: staff, children and parents. Abiding by the terms of the club's mobile phone policy ensures that we all:

- Protect children from harm and abuse
- Prevent staff from being subject to false allegations
- Help staff remain focused on the care of children
- Work in an open and transparent environment.

With the evolution of mobile phones, tablet computers and wearable technology that have camera facilities and sharing capabilities as standard, it is of the utmost importance that the way we deal with technology is handled safely.

Staff use of mobile phones and wearable technology

Personal mobile phones belonging to members of staff are kept with personal belongings in a place agreed by the camp leader, usually the kitchen area during working hours.

Only the Head Coach or Camp Leader should be on their phone during working hours of a Konnect With Sport holiday camp. For example, contacting parents/carers or completing any administrative tasks. This should be done away from children.

If a member of staff needs to make an urgent personal call, they can use their mobile phone to make a personal call away from the children. This should be pre-arranged with the Head Coach or Camp leader.

If a member of staff has a family emergency or similar and needs to keep their mobile phone to hand, prior permission must be sought from the Head Coach or Camp Leader.

Under no circumstances may staff use their personal mobile phones/smart watches and similar devices to take photographs at the club during working hours.

Wearable technology such as smart watches, Fitbits etc. can be worn during the camp day but must not be used to take photos during the day or used to access the internet. These smart watches should be changed to "flight mode" while working with children so only the watch part of the phone is accessible. Head Coach or Camp Leader will have the right to check this functionality with the staff on site in order to protect children and staff from false allegations.

Only tablets computers that are owned and maintained by Konnect With Sport can be used on site. These can be used to take photos of children where permissions from parents/carers have been sought for a particular.

Children’s use of mobile phones and wearable technology

Whilst we understand that some children have mobile phones and smart watches, we actively discourage them from using their phones and wearing the watches within our clubs. Mobile phones and smart watches should be handed back to the parent/carer on arrival to our club. If a mobile phone, tablet computer or wearable device with camera or sharing facilities is seen by a member of staff, the item will be kept safely by the Head Coach or Camp leader and returned to the parent/carer on collection of the child.

Konnect With Sport does not accept any responsibility for loss or damage to mobile phones, tablet computers or wearable technology brought to the club by the children and we would suggest they are taken home by parent/carer.

Children must not use their mobile phone or wearable technology to take photographs of any kind whilst at the club. If they want a photograph of a particular activity they can ask a member of staff to take one using the company iPad.

Children must not use their mobile phone or wearable technology to access the internet whilst at the club. This is to ensure we are safeguarding the welfare of all children whilst they are attending our clubs.

Under no circumstances are staff allowed to take photographs of the children using personal mobile phones/watches or any other smart technology.

Visitors’ use of mobile phones

Parents and all other visitors must not use their mobile phone – or any other device - to take photographs within the camp. This includes taking photographs of their own children. If they want to have a photograph of their child involved in an activity or at play, parents can ask a member of staff to take one using the company iPad. If a parent/guardian arrives at a club/camp on their phone they will be politely asked to turn it off or finish their call outside away from the areas used by the club/camp.
